### The purposes of the processing

The data concerning you, collected in this form (hereinafter the "Form") on a voluntary basis, are processed by the Directorate to enable it to:

- to register you for the service of sending you free updates of the paper information sheets and the binder "Konsumenteschutz: Guide fir de Professionellen - Matenee Vertraue Gewannen." published by the Directorate (hereinafter the "Binder") allowing you to file the sheets; and
- where applicable, to explicitly authorise the Directorate to contact you to participate in the improvement and development of the contents of the Binder.

#### Lawfulness of data processing

The Directorate carries out this processing based on your consent. Please note that you have the right to withdraw your consent at any time (without prejudice to the lawfulness of processing based on consent given prior to withdrawal of consent). To exercise your right to withdraw your consent, please contact our Data Protection Officer specifying the processing for which you wish to withdraw your consent.

### Collection of data from the data subject: the obligation to provide data and the consequences of refusing to provide it.

The provision of data by you is required to enable the Department to provide you with the requested service. A refusal by you to provide the requested data will result in the cancellation of the requested service.

### Place of storage and duration of storage

The data collected in this Form are stored and processed on the State's IT infrastructure managed by the State Information Technology Centre (Centre des technologies de l'information de l'État, CTIE).

Your data is in principle processed within the European Economic Area.

The duration of the storage of personal data is limited to the duration of the company's registration for the binder update service.

The above retention periods apply without prejudice to any further processing for compatible purposes, in particular for statistical or scientific research purposes or for archival purposes in the public interest (in particular their deposit and conservation by the National Archives) or for the purposes of legal proceedings in progress.

### The rights of the data subject

In accordance with the GDPR, you have (i) a right of access, (ii) a right to withdraw consent, (iii) a right of rectification, (iv) a right to erasure of your data and (v) a right to restriction of processing.

The processing of your data does not involve automated decision-making which produces legal effects concerning you or which affects you significantly in a similar way.

### Complaint to the National Commission for Data Protection (CNPD)
